

OFFICIAL RULES

Wegmans Panel Sweepstakes

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. Wegmans Panel Sweepstakes (the "Sweepstakes") period begins December 1, 2018 and ends November 30, 2019.

ELIGIBILITY

Open to legal residents of New Jersey, New York, Pennsylvania, Maryland, Massachusetts, North Carolina and Virginia age 18 or over on date of entry, except for employees, representatives, and principals (or members of the immediate families or households of same) of Wegmans Food Markets, Inc. or Vision Critical (US), Inc. or any of their parent companies, subsidiaries, affiliates, advertising or promotional agencies. Eligibility for any specific drawing is limited to those Panelists who receive a survey invitation and timely respond to it in the applicable month as set forth below.

MONTHLY PRIZES:

Prizes are as stated in promotional literature and cannot be transferred, exchanged or redeemed for cash or other merchandise.

Prizes will be awarded as follows: a \$100.00 Wegmans Gift Card (thirty-six (36) winners). During the sweepstakes, three (3) \$100.00 Wegmans Gift Cards will be awarded each month from all completed Wegmans Customer Panel surveys received in that month.

Total value of prizes to be awarded per year is \$3,600. Prizes are non-transferable, non-substitutable, and may not be redeemed for cash. Wegmans or Sponsor(s) reserves the right to substitute prizes of equal or greater value. All applicable federal, state and local taxes are the responsibility of the winner.

The number of surveys that will take place between December 2018 and November 2019 will be determined by Wegmans. The promotion officially ends 11/30/2019.

HOW TO ENTER

Survey invitations will be sent by email periodically to Panelists selected by Sponsor during the monthly recruiting period. Not all Panelists will receive survey invitations each month, and some Panelists may receive multiple invitations. No purchase is necessary to obtain a survey invitation or to respond to a survey. Any Panelist receiving a survey invitation is eligible to obtain an entry by responding to the survey. To complete the survey, check your email for a survey link. Respond to the survey as directed within the designated time period.

Each completed survey responded to on the website shall receive one (1) entry to the applicable drawing(s) as described below. The more surveys you respond to the greater your odds of winning. Unselected entries will not be eligible for subsequent draws. All surveys and information become the property of Wegmans and will not be returned. All entries must be received by the Administrator on or before the entry deadline for the applicable month as detailed below to be eligible for a prize. Limit one (1) prize per person.

To qualify, all online surveys must be received by the deadline given for each individual survey.

THE DRAWINGS

Each month three (3) winners will be selected in a random drawing from all completed surveys received, to be held on or about thirty (30) days after survey deadline, by Wegmans officials whose decisions are final with respect to all matters relating to this promotion.

Any entry is eligible for no more than one Monthly Drawing; if unselected in a drawing, the entry is not eligible for any

subsequent drawing. If a selected entrant chooses not to accept the prize, or is otherwise disqualified from winning the prize, the prize will be deemed to be forfeited and no substitution or other compensation will be awarded to that entrant and an alternate winner will be selected.

The selected entrant(s) will be contacted by telephone or email within ten (10) days of drawing. If the selected entrant does not comply with the Sweepstakes Rules or cannot be contacted by telephone or email despite diligent efforts to do so within fourteen (14) days, that entrant will be disqualified and an alternate winner will be chosen. Winner must be at least 18 years of age. The prize will be sent to the winner within 4-6 weeks of receipt of the declaration and release of liability. ODDS OF WINNING

Odds of winning a Monthly Prize depend on the number of eligible entries received by Administrator for each of the Panels.
